






Alternative financing provides financial access to people who would normally not qualify for traditional financing.

The Center for Financial Independence and Innovation (CFII) takes financial access a step further with the addition of our financial education services. Services are offered in person, over the phone, or via webinar. Print materials can be provided in a variety of alternate formats upon request. The Center for Financial Independence and Innovation

The Center for Financial Independence and Innovation (CFII) seeks to empower people with disabilities to become more financially secure through our programs. People with disabilities should have opportunities for self-determination, and we want to provide opportunities to advance these goals through our services. The CFII is a certified Community Development Financial Institution with a focus of serving the disability community in Georgia.

The Credit-Able Assistive Technology Loan Program provides loans of up to \$10,000 at a 3-8% interest rate to people with disabilities in Georgia to acquire necessary assistive technologies. We offer flexible terms of up to 8 years, based on the life of the device, to fit the budget of people with disabilities.

The First \$TEP Program provides small credit builder loans to assist Georgians with disabilities to build or repair their credit. Interest rates are 4% and up to \$1,000 can be loaned for up to 18 months. These small loans are perfect for people who have never had the opportunity to establish or rebuild their credit.

Financial Education is the cornerstone of successfully managing your money and building your credit, we want to ensure that people with disabilities have the knowledge they require to become empowered and achieve financial independence. We will work one-on-one, in groups, or online to present information on banking, credit, avoiding scams, and making informed decisions when it comes to assistive technology and asset management. Our financial education services are free of charge.

Low-Cost or No-Cost Equipment


The Georgia Telecommunications Equipment Distribution Program (GATEDP) is a program enacted by the Georgia Legislature that provides specialized telecommunication equipment to Georgia residents with hearing and/or speech impairments.



The National Deaf-Blind Equipment Distribution Program (NDBEDP) enables low-income individuals who are deaf-blind to access 21st Century communications services.

This program will help ensure that qualified individuals have access to the internet and advanced communications.

Through the **National Federation of the Blind**, any blind individual in the fifty states, the District of Columbia, and Puerto Rico may request a cane for their personal use. Requests may be made as often as every six months.


